

Requirements for the Transfer of Corporate Share (Class C)

- 1. Duly completed Membership Application Form each from the 1st and 2nd nominee/ assignee. <u>Please indicate N/A for information that is not applicable.</u>
- Originally signed two (2) Letters of Endorsement each for the 1st and 2nd nominee/ assignee from a regular/ proprietary/ corporate nominee/ assignee member in good standing of the Club.
- 3. Original & Notarized Deed of Sale, Capital Gain Tax Return, BIR Certification and duly endorsed copy of the Stock Certificate of the Seller. All original documents are to be forwarded by the buyer to Sta. Lucia for the processing of the Stock Certificate.
- 4. Original & Notarized Board Resolution/ Secretary's Certificate indicating the nominee/ assignee members to the Club and their positions in the company.
- 5. Original Letter of Appointment on who will shoulder the monthly dues and other assessments.
- 6. Original Letter of Transfer addressed to the Membership Committee endorsing the Transferee/ Buyer.
- 7. Three (3) pieces 2x2 colored picture with white background from each of the 1st and 2nd nominee/ assignee (colored with white background)
- 8. Surrender of membership card/s issued to the current nominees/ assignees and dependent/s.
- 9. Original Certificate of Employments and copy of Company IDs from the 1st and 2nd nominees/ assignees
- 10. Presentation of Original Passports from the 1st and 2nd nominee/ assignee (or any valid IDs for local Applicants)
- 11. Copy of SEC Certificate of Registration, Articles of Incorporation, & By-Laws, latest General Information Sheet, Company's Tax Identification Number, and Audited Financial Statement of the company where the applicant is connected as employee/ director or stockholder; Copy of DTI Certificate of Business Registration and Business Permit and other documentary proof of business or employment as may be required.
