



**Requirements for the Transfer of Individual Corporate Share
(Class A or Class B)**

1. Duly completed Membership Application Form. Please indicate N/A for information that is not applicable.
2. Originally signed two (2) Letters of Endorsement from a regular/ proprietary/ corporate nominee/ assignee member in good standing of the Club.
3. Original & Notarized Deed of Sale, Capital Gain Tax Return, BIR Certification and duly endorsed Stock Certificate of the Seller. All original documents are to be forwarded to Sta. Lucia for the processing of the Stock Certificate in favor of the buyer.
4. Original & Notarized Board Resolution/ Secretary's Certificate indicating the nominee/ assignee member to the Club and his/her position in the company and appointing the authorized officer to sign on behalf of the company for the sale/purchase of the share
5. Original Letter of Appointment on who will shoulder the monthly dues and other assessments.
6. Original Letter of Transfer addressed to the Membership Committee endorsing the Transferee/ Buyer.
7. Photocopy of PSA- certified Birth Certificate of the principal applicant.
8. Three (3) pieces 2x2 colored pictures with white background.
9. Surrender of membership card/s issued to the current nominees/ assignees and dependent/s.
10. Original Certificate of Employment and copy of Company ID
11. Presentation of Original Passport (or any valid ID for local Applicants), prepare a photocopy with 3 specimen signatures of both buyer & seller.
12. Copies of the following:
 - a. SEC Certificate of Registration, Articles of Incorporation, & By-Laws, latest General Information Sheet, Company's Tax Identification Number, and Audited Financial Statement of the company where the applicant is connected as employee/ director or stockholder;
 - b. Copy of DTI Certificate of Business Registration and Business Permit
 - c. Other documentary proof of business or employment as may be required.
